We also retain a technical director to monitor and report on global technical developments that affect silver consumption.

The Silver Institute releases the annual World Silver Survey, to bring timely and reliable silver supply and demand statistics and market analysis to market participants and the general public. It is widely referenced and is the most quoted report on the silver market.
